## I. WORLD PRESS SUMMARY: INTERNATIONAL NEWS

### INDONESIA: THIRD WORLD DEVELOPMENT IN ADVANCED SECTOR SELF-INTEREST

CHICAGO, OCT. 3 (IPS)—SPEAKING BEFORE THE UNITED NATIONS ASSOCIATION OF CHICAGO, ADAM MALIK, THE FOREIGN MINISTER OF INDONESIA, DECLARED IT TO BE THE "LONG-TERM INTEREST OF ALL GREAT POWERS TO ASSIST US IN ECONOMIC DEVELOPMENT, EVEN IF IT APPEARS TO BE A TEMPORARY DISADVANTAGE." AFTER HIS SPEECH, MALIK REPLIED TO AN IPS QUESTION REGARDING HIS POSITION ON DEBT MORATORIUM BY SAYING THAT HE "SUPPORTS DEBT MORATORIUM BUT SO DOES THE WORLD BANK." WHEN IPS POINTED OUT THAT WORLD BANK SUPPORT FOR DEBT MORATORIUM WAS ONLY SELECTIVE AND THAT THE U.S. IS OPPOSED TO IT, HE QUICKLY AGREED. MALIK ALSO SAID HE HAD DISCUSSED THE QUESTION OF THE TRANSFERABLE RUBLE WITH THE SOVIETS AND THAT THE SOVIETS HAD IN FACT GRANTED INDONESIA A 30-YEAR EXTENSION ON A \$1 BILLION DEBT.

### MPLA REPORTS ADVANCE IN CENTRAL ANGOLA AFTER TEN DAYS OF RETREAT IN NORTH AND SOUTH

OCT. 3 (IPS)—THE POPULAR MOVEMENT FOR THE LIBERATION OF ANGOLA (MPLA) REPORTS IT HAS PENETRATED INTO THE PROVINCE OF HUAMBO, WHOSE CAPITAL IS NOVA LISBOA, THE CHIEF STRONGHOLD OF THE CIA-RUN NATIONAL UNION FOR THE TOTAL INDEPENDENCE OF ANGOLA (UNITA). THE MPLA FOUND THE POPULATION THERE LIVING UNDER "CATASTROPHIC CONDITIONS" AND REPORTED THAT THE CIA'S UNITA AND NATIONAL FRONT FOR THE LIBERATION OF ANGOLA (FNLA) MERCENARIES WERE BOTH FIGHTING EACH OTHER AND ABUSING THE POPULATION, ACCORDING TO PRENSA LATINA TODAY.

### U.S.—POLISH TRADE OUTLOOK BRIGHT, NO THANKS TO FORD, TRIBUNE REPORTS

OCT. 3 (IPS)—CREDITING FORMER PRESIDENT NIXON WITH INITIATING INCREASED TRADE BETWEEN THE U.S. AND POLAND, POLISH OFFICIALS WELCOMED INTERNATIONAL HARVESTER OFFICIAL BROOKS MCCORMICK AND A 44-MEMBER DELEGATION OF AMERICAN BUSINESSMEN TO WARSAW WITH HEAVILY FAVORABLE NEWS MEDIA COVERAGE RECENTLY, ACCORDING TO SYNDICATED COLUMNIST BILL ANDERSON IN YESTERDAY'S CHICAGO TRIBUNE. "I DON'T THINK YOU CAN SAY THAT MR. FORD WAS THE ADVANCE MAN," THE PRESIDENT OF THE POLISH CHAMBER OF FOREIGN TRADE POINTEDLY TOLD

IN LATE APRIL, REPRESENTATIVES OF THE SOUTH AFRICAN COMMUNIST PARTY, NOW IN EXILE IN LONDON, WERE INVITED BY THE PCF TO MAKE AN ORGANIZING TOUR OF THE PARIS AREA "RED BELT" WITH PCF OFFICIALS, ACCORDING TO THE AFRICAN COMMUNIST.

#### MAOISM, ITALIAN-STYLE

OCT. 3 (IPS)—GIANNI AGNELLI, PRESIDENT OF THE ITALIAN INDUSTRIALISTS' ASSOCIATION, THE CONFINDUSTRIA, IS NOW IN CHINA ATTEMPTING TO DETERMINE THE REASONS FOR CHINESE "SUCCESS" IN OBTAINING SACRIFICES FROM ITS PEOPLE, ACCORDING TO AVANTI, DAILY OF THE ITALIAN SOCIALIST PARTY. AVANTI COMMENTS THAT CHINA IS SEEKING TO OPEN ITS DOORS TO THE WEST BECAUSE "ESPECIALLY SINCE THE BREAK WITH THE SOVIET UNION, CHINA'S GROWTH HAS BEEN VERY SLOW AND ENTIRELY BASED ON THE SACRIFICES OF ITS PEOPLE."

#### PORTUGUESE SOCIALISTS BEHIND NEW INSURRECTIONIST ACTIVITIES

OCT. 3 (IPS)—SIMULTANEOUSLY WITH THE PORTUGUESE SOCIALIST PARTY'S (PSP) "COUP WARNINGS" IN LISBON OCT. 1, COMMUNIQUEES WERE RELEASED IN INTERIOR CITIES OF THE COUNTRY WARNING OF A COUP ATTEMPT BY "ULTRAMINORITY PROVOCATEUR GROUPS OF THE PSEUDOLEFT AT THE SERVICE OF THE CIA AND THE REACTION." IN THOSE CITIES "A CALL TO ARMS WAS SOUNDED WITH THE RINGING OF CHURCH BELLS AND A MARCH ON LISBON WAS CALLED FOR," YESTERDAY'S LISBON PRESS REPORTS. A SIMILAR "MARCH ON LISBON" BROUGHT THE DEPOSED FASCIST DICTATORSHIP OF ANTONIO SALAZAR TO POWER IN 1928.

PSP LEADERS ALSO ASKED PRIME MINISTER AZEVEDO TO DECLARE A STATE OF EMERGENCY, WHICH WAS REJECTED BY THE CHIEF OF STATE, WHO SAID THAT HE SAW NO MOTIVE FOR SUCH EXTREME MEASURES. THIS INFORMATION WAS PUBLISHED IN A PRENSA LATINA DISPATCH YESTERDAY.

#### NEW BRD MEDIA FORCES JOIN EFFORT TO MOP UP CIA AGENT WILLY BRANDT

OCT. 3 (IPS)—GERHARD LOEWENTHAL, A POPULAR RADIO BROADCASTER FOR THE CHANNEL 2 WEST GERMAN RADIO STATION, TODAY ACCUSED WEST GERMAN SOCIAL DEMOCRATIC AGENT WILLY BRANDT OF HAVING PERJURED HIMSELF DURING A COURT INVESTIGATION INTO THE GUENTHER GUILLAUME SPY AFFAIR, WHICH PROMPTED BRANDT'S RESIGNATION FROM THE FEDERAL CHANCELLORSHIP IN APRIL 1974. LOEWENTHAL CHARGED THAT BRANDT'S PLEADING THAT HE WAS IGNORANT OF "INTELLIGENCE MATTERS" AND THEREFORE DID NOT KNOW THAT WEST GERMAN INTELLIGENCE OFFICIALS SUSPECTED GUILLAUME—A TOP AID TO BRANDT—OF BEING AN EAST GERMAN SPY WAS LUDICROUS. LOEWENTHAL NOTED THAT BRANDT HAD WORKED WITH THE U.S. OFFICE OF STRATEGIC SERVICES (OSS) DURING WORLD WAR II.

LOEWENTHAL'S CHARGE OF PERJURY AGAINST BRANDT IS PART OF THE BROAD, INTERNATIONAL EXPOSURE OF BRANDT'S AGENT ACTIVITIES FOR THE CIA.

A PRESS CONFERENCE HELD YESTERDAY IN BONN, WEST GERMANY, BY THE EUROPEAN LABOR COMMITTEES, DOCUMENTING ELC CHARGES THAT BRANDT

IS A CIA AGENT AND A FASCIST, WAS WELL ATTENDED BY EAST BLOC PRESS REPRESENTATIVES AND THE WEST GERMAN AND SCANDINAVIAN SOCIAL DEMOCRACIES. A LAWSUIT BY BRANDT AGAINST LEADING MEMBERS OF THE ELC FOR HAVING MADE THE CITED CHARGES WILL GO TO COURT AT THE END OF OCTOBER.

#### FRENCH STEEL BOSS CALLS FOR IMPORT RESTRICTIONS TO "SOLVE" STEEL COLLAPSE

OCT. 3 (IPS)—FRENCH STEEL INDUSTRIES HEAD JACQUES FERRY APPARENTLY LOST CONTROL OF HIMSELF AT A RECENT MEETING OF THE EUROPEAN COAL AND STEEL COMMUNITY (ECSC) CONSULTATIVE COMMITTEE MEETING AND OPENLY CALLED FOR PROTECTIONIST IMPORT RESTRICTIONS ON COAL AND STEEL, ACCORDING TO THE OCT. 1 LE MONDE. FERRY, A MEMBER OF THE COMMITTEE, WARNED THE GROUP THAT UNLESS THEY DECLARE THE EUROPEAN STEEL SECTOR TO BE A "MANIFEST DISASTER," "THE COMMON MARKET WOULD BE THREATENED WITH DISINTEGRATION."

FERRY'S REACTION WAS IN RESPONSE TO THE MORE THAN 25 PER CENT DROP IN EUROPEAN STEEL PRODUCTION IN THE PAST YEAR. IN SOME CASES, EUROPEAN STEEL SALES HAVE DROPPED BY AS MUCH AS 40 PER CENT ON WORLD MARKETS.

#### WEST GERMAN PRESS SCANDAL BLACKS OUT SCHLESINGER'S EUROPEAN TRIP

OCT. 3 (IPS)—A SCANDAL MANUFACTURED IN THE WEST GERMAN PRESS ABOUT A TRIP MADE TO SOUTH AFRICA LAST OCTOBER BY A WEST GERMAN AIR FORCE LT. GENERAL, GUENTHER RALL, IS BEING USED TO COVER A WEST GERMAN PRESS BLACK-OUT AROUND U.S. DEFENSE SECRETARY JAMES SCHLESINGER'S CURRENT TRIP TO EUROPE. ALTHOUGH RALL'S VISIT TO A SOUTH AFRICAN NUCLEAR INSTALLATION IS GIVEN BANNER HEADLINES, WEST GERMAN PAPERS HAVE UTTERLY BLACKED OUT SCHLESINGER'S VISIT TO FRENCH NUCLEAR INSTALLATIONS.

RALL, WHO IS THE WEST GERMAN MEMBER OF THE IMPORTANT NATO MILITARY COMMITTEE, HAS NOT COMMENTED AT ALL ON HIS SOUTH AFRICAN TRIP, WHICH HE UNDERTOOK UNDER AN ASSUMED NAME. THE LEAD EDITORIAL IN YESTERDAY'S FRANKFURTER RUNDSCHAU COMMENTS THAT "IT IS NOW BECOMING EVIDENT THAT THERE ARE PEOPLE IN THE MILITARY LEADERSHIP WHO DO NOT NOW SEEM TO BE LIMITING THEMSELVES JUST TO HAVING OTHER OPINIONS, BUT ARE OBVIOUSLY SEEKING CONTACTS AND DUTIES WHICH ARE DIAMETRICALLY OPPOSED TO BONN'S." ANALYSTS SUGGEST THAT SUCH NONSENSE MAY BE PREPARATORY TO A PURGE OF MILITARY LEADERS IN WEST GERMANY OPPOSED TO SCHLESINGER'S "LIMITED NUCLEAR WAR" STRATEGY.

#### II. WORLD PRESS SUMMARY: CONTINENTAL NEWS

##### PIKE COMMITTEE BACKS DOWN ON CLASSIFIED DOCUMENTS CONFRONTATION, LEAVES SOME OPTIONS OPEN

OCT. 3 (IPS)—THE HOUSE SELECT COMMITTEE ON INTELLIGENCE AGREED IN A 10 TO 3 VOTE TO ACCEPT PRESIDENT FORD'S CONDITIONS THAT THEY

NOT MAKE PUBLIC SECRET MATERIALS OR TESTIMONY GIVEN TO IT BY THE EXECUTIVE BRANCH, ACCORDING TO TODAY'S NEW YORK TIMES. WHILE THE COMMITTEE, HEADED BY REP. OTIS PIKE, HAS BACKED DOWN ON THIS ISSUE, THEY STILL HAVE A NUMBER OF OPTIONS, INCLUDING SEEKING A FULL HOUSE VOTE ON A RESOLUTION, NOW PENDING IN THE RULES COMMITTEE, WHICH WOULD DECLARE ADMINISTRATION OFFICIALS IN CONTEMPT OF CONGRESS.

IN A RELATED CONGRESSIONAL CAPITULATION, THE HOUSE OF REPRESENTATIVES VOTED 267 TO 147 TO KEEP THE BUDGET OF THE CIA SECRET FROM THE PUBLIC.

#### DRUG USE SOARS BUT ADDICTION DOWN, CIA STUDY SAYS

OCT. 3 (IPS)—THE NATIONAL INSTITUTE ON DRUG ABUSE HAS "DETERMINED THAT HEROIN ADDICTION IS 90 PER CENT LESS THAN PREVIOUSLY BELIEVED," WHILE ADMITTING THAT DRUG USE AMONG AMERICAN TEENAGERS IS SOARING AND IS BEGINNING AT AN EARLIER AGE THAN EVER BEFORE, ACCORDING TO A STUDY RELEASED WEDNESDAY.

BUT NIDA, A SISTER INSTITUTE OF THE CIA-CONTROLLED NATIONAL INSTITUTE OF MENTAL HEALTH, RATIONALIZES ITS CONTRADICTIONARY CONCLUSION BY CLAIMING THAT LONG-TERM "EXPERIMENTATION" WITH HEROIN DIFFERS FROM "ADDICTION," ACCORDING TO TODAY'S NEW YORK TIMES. NIDA CONCEDES, FOR EXAMPLE, THAT 80 PER CENT OF U.S. ARMED FORCES VIETNAM VETERANS "STILL USE HEROIN" BUT 70 PER CENT OF THESE WERE "NO LONGER ADDICTED."

#### STATE CONTROLLER LEVITT UNDER "SEVERE PRESSURE" TO RELEASE PENSION FUNDS TO ROCKEFELLER

OCT. 3 (IPS)—NEW YORK STATE CONTROLLER ARTHUR LEVITT, THE SOLE TRUSTEE FOR STATE CIVIL SERVICE EMPLOYEE PENSION FUNDS, IS UNDER "SEVERE PRESSURE" TO REVERSE HIS STATED REFUSAL TO INVEST PENSION FUNDS IN WORTHLESS MUNICIPAL ASSISTANCE CORPORATION (MAC) BONDS, ACCORDING TO TODAY'S NEW YORK TIMES. REPORTEDLY, AIDES TO GOV. CAREY ARE CONSIDERING LEGISLATION WHICH WOULD ADD TWO OTHER TRUSTEES TO THE PENSION SYSTEM WHO COULD OVERRULE LEVITT ON THIS ISSUE.

THE STATE TEACHERS' RETIREMENT SYSTEM, ANOTHER PENSION SYSTEM, IS ALSO REPORTEDLY PLANNING TO CHALLENGE STATE LEGISLATION ORDERING IT TO INVEST THE PENSION FUNDS IN MAC BONDS. THE NEW YORK STATE COURT OF APPEALS, THE STATE'S HIGHEST COURT, IN A RULING ISSUED SEPT. 29, RULED THAT A LAW ORDERING LEVITT TO INVEST PENSION FUNDS IN MAC WAS INVALID.

#### CHICAGO POLICE, NOT SECRET SERVICE, ARREST WOMAN WITH PISTOL AT FORD VISIT SITE

OCT. 3 (IPS)—LOCAL CHICAGO POLICE, PART OF AN EXTRAORDINARY PROTECTIVE NET ORDERED BY CHICAGO MAYOR RICHARD DALEY TO PROTECT PRESIDENT FORD ON HIS VISIT HERE, APPREHENDED A WOMAN CARRYING AN UNLICENSED PISTOL NEAR THE CONRAD HILTON HOTEL, 15 MINUTES BEFORE THE PRESIDENT ARRIVED AT THE HOTEL, THE OCT. 1 NEW YORK POST REPORTED. SECRET SERVICEMEN WERE NOT INVOLVED IN THE APPREHENSION, DESPITE THEIR EXTRAORDINARY DEPLOYMENT TO CHICAGO FOR THE PRESIDENTIAL VISIT.

PRESIDENTIAL PRESS SECRETARY RON NESSEN QUICKLY DENIED THAT THE WOMAN HAD BEEN A THREAT TO FORD, WHO IS UNDER HEAVY CRITICISM FOR UNNECESSARILY EXPOSING HIMSELF TO ASSASSINATION ATTEMPTS. BUT, ACCORDING TO A MEMBER OF THE CHICAGO POLICE, THE WOMAN TOLD ARRESTING OFFICERS THAT "SHE WAS WAITING FOR THE PRESIDENT."

#### CHARLOTTE SCENARIO APPEARS IN SAN FRANCISCO

SAN FRANCISCO, OCT. 3 (IPS)—AT A CANDIDATES NIGHT HELD OCT. 1 IN THE POSH NOB HILL SECTION OF SAN FRANCISCO, AN UNIDENTIFIED, VIRTUALLY INCOHERENT WOMAN TRIED TO INTRODUCE HERSELF AS A LABOR PARTY CANDIDATE.

WHEN LABOR PARTY MEMBERS INTERVENED AND ATTEMPTED TO QUESTION THE WOMAN, SHE FLED. THE LABOR PARTY STATED THAT IT WILL ASK THE CALIFORNIA ATTORNEY GENERAL TO INVESTIGATE THE CASE AND WILL UNDERTAKE ITS OWN INVESTIGATION TO DETERMINE WHETHER SIMILAR FRAUDS ARE NOT BEING UNDERTAKEN ELSEWHERE BY POLICE AGENTS ANXIOUS TO DISCREDIT THE USLP.

THE NATIONAL SECURITY COUNCIL HAS TAKEN SUCH FRAUD TO AN EXTREME IN CHARLOTTE, NORTH CAROLINA, WHERE POLICE AGENTS ARE NOW RUNNING FOR MAYOR ON THE USLP TICKET.

#### BANKER HANGS UP ON "SOCIALISTS," WILL SPEAK TO "COMMUNISTS"

OCT. 3 (IPS)—A SPOKESMAN FOR THE EUROPEAN-AMERICAN BANK IN NEW YORK CITY, A BANK THAT IS A CONSORTIUM OF THE FIVE LARGEST EUROPEAN BANKS, ABRUPTLY HUNG UP ON A U.S. LABOR PARTY ORGANIZER IN THE MIDST OF A DISCUSSION ON EXPANDED EAST-WEST TRADE YESTERDAY. THE ORGANIZER HAD MENTIONED THAT HIS POLITICS WERE "SOCIALIST." HOWEVER, WHEN CALLED AGAIN AND INFORMED THAT THE USLP WOULD HAVE TO BE CONSIDERED COMMUNIST BECAUSE OF ITS OPPOSITION TO SUCH PRO-CIA SOCIAL DEMOCRATS AS WILLY BRANDT AND MARIO SOARES, THE EUROPEAN-AMERICAN SPOKESMAN QUICKLY RESUMED THE CONVERSATION, NOTING, "I SEE THE DIFFERENCE."

#### MAYOR, POLICE CHIEF SUED BY GREENSBORO, NORTH CAROLINA LABOR PARTY

GREENSBORO, N.C., OCT. 3 (IPS)—MARION PORTER, MICHAEL SMEDBURG AND AL FRIPP, LABOR PARTY CANDIDATES IN THE OCT. 7 GREENSBORO, N.C., PRIMARIES, FILED SUIT IN FEDERAL COURT OCT. 1 AGAINST GREENSBORO MAYOR JAMES MELVIN, THE CITY POLICE CHIEF AND THE CITY'S HEAD OF PUBLIC SAFETY FOR VIOLATIONS OF THE LABOR PARTY'S CIVIL RIGHTS. CHARGES STEM FROM THREE ARRESTS OF THE CANDIDATES WHILE CAMPAIGNING, MADE UNDER THE CITY'S RARELY USED SOUND RESTRICTION ORDINANCE. THE WAVE OF ARRESTS, WHICH HAVE BROUGHT MANY WORKERS WHO SAW THE ARRESTS AS "ATTACKS ON THE DEBT MORATORIUM" INTO ACTIVE LABOR PARTY CAMPAIGN WORK, BEGAN THREE WEEKS AGO AFTER MAYORAL CANDIDATE MARION PORTER BRIEFED THE CITY COUNCIL ON THE URGENCY OF A DEBT MORATORIUM AND IN PARTICULAR THE ALREADY DANGEROUS LEVEL OF HEALTH CRISIS IN THE CITY DUE TO DEBT-FORCED AUSTERITY. MAYOR MELVIN, A LACKLUSTER BANKER, AND COUNCILMAN MARY SEYMOUR, WHO FACES PORTER IN THE ELECTIONS, BECAME HYSTERICAL AND SUBSEQUENTLY ORDERED POLICE TO STOP THEIR OPPONENTS.
