SOURCES CONFIRM AUTHENTICITY OF MANSON LETTER TO USLP;
LEVI CONTINUES TO STONEWALL

NOV. 17 (IPS)—THE U.S. LABOR PARTY TODAY OBTAINED CONFIRMATION OF THE AUTHENTICITY OF A THREATENING LETTER SIGNED BY PSYCHOTIC MURDERER CHARLES MANSON FROM TWO SEPARATE SOURCES.

QUALIFIED SOURCES IN THE SAN FRANCISCO PRESS CORPS TODAY INFORMED THE LABOR PARTY THAT SANDRA GOODE, MEMBER OF THE MANSON FAMILY AND ROOMMATE OF WOULD-BE PRESIDENTIAL ASSASSIN LYNETTE (SQUEAKY) FROMME, HAD IDENTIFIED THE LETTER, RECEIVED BY THE USLP'S SAN FRANCISCO OFFICE NOV. 8, AS BEING WRITTEN BY MANSON.

SIMULTANEOUSLY, SPECIAL AGENT FREDERICKS OF THE CALIFORNIA CORRECTIONAL DIVISION AT SAN QUENTIN PRISON, WHO SAYS HE KNOWS MANSON VERY WELL, TOLD THE LABOR PARTY THAT THE LETTER "LOOKS LIKE MANSON'S HANDWRITING." CONVICTED MURDERER MANSON IS CURRENTLY IMPRISONED AT SAN QUENTIN.

DESPITE THE INCREASING EVIDENCE OF THE ASSASSINATION THREAT TO LABOR PARTY PRESIDENTIAL CANDIDATE LYNDON LAROCHE, JR., BOTH ATTORNEY GENERAL EDWARD LEVI'S JUSTICE DEPARTMENT AND THE FBI ARE STONEWALLING AN INVESTIGATION OF THE MANSON LETTER.

THE LABOR PARTY WAS TOLD IN WASHINGTON, D.C. BY JUSTICE DEPARTMENT OFFICIAL CUBBAGE THAT THE JUSTICE DEPARTMENT HAD ORDERED THE FBI TO CARRY OUT AN INVESTIGATION. HEAD OF THE CRIMINAL JUSTICE DIVISION IN THE U.S. ATTORNEY'S OFFICE IN SAN FRANCISCO, F. STEELE LANGFORD, TOLD THE USLP THAT HE HAD HEARD FROM "HIS SECRETARY" THAT CUBBAGE HAD TOLD THE FBI IN SAN FRANCISCO TO CARRY OUT "SOME MORE INTERVIEWS."

HOWEVER, WHEN THE SAN FRANCISCO FBI OFFICE WAS CONTACTED TO CONFIRM THE REPORT, FBI SPOKESMAN TIBALDI TERMED THE INFORMATION "PRIVILEGED" AND REFUSED TO CONFIRM THAT AN INVESTIGATION WAS TAKING PLACE.
