**LAROUCHE CANCELS SAN FRANCISCO CAMPAIGN APPEARANCE;  
WARNS OF CONTINUED ASSASSINATION/TERRORISM DANGER**

**CHICAGO, NOV. 19 (IPS) — U.S. LABOR PARTY PRESIDENTIAL CANDI-  
DATE LYNDON LAROUCHE, JR. ANNOUNCED HERE THIS AFTERNOON THAT HE HAD  
CANCELLED HIS SCHEDULED CAMPAIGN APPEARANCE IN SAN FRANCISCO BE-  
CAUSE OF THE JUSTICE DEPARTMENT'S CONTINUED COVERUP OF THE ASSASS-  
INATION THREAT RECEIVED FROM THE MANSON FAMILY.**

**IN ANNOUNCING THE CANCELLATION, LAROUCHE CITED THE COINCIDENCE  
OF THE LETTER RECEIVED BY THE EUROPEAN LABOR COMMITTEE IN WEST  
GERMANY ATTEMPTING TO LINK THE LABOR COMMITTEES WITH THE BAADER-  
MEINHOF TERRORIST GANG, THE ASSASSINATION THREATS DIRECTED  
AGAINST THE LABOR COMMITTEES IN MEXICO BY THE CIA-CONTROLLED SEP-  
TEMBER 23 TERRORIST GANG, AND THE THREATS DIRECTED AT THE U.S.  
LABOR PARTY IN THE U.S. BY THE MANSON FAMILY.**

**"SUCH AN INTERNATIONALLY-COORDINATED SERIES OF THREATS AND SIG-  
NALS FOR A TERRORIST HAVE MUST NECESSARILY BE UNDER THE CONTROL  
OF THE NATIONAL SECURITY COUNCIL, AND COMES FROM DIRTY OLD NELSON  
ROCKEFELLER HIMSELF," SAID LAROUCHE. "ATTORNEY GENERAL EDWARD  
LEVI IS WILFULLY AND DELIBERATELY COVERING UP THE U.S. END OF  
THIS INTERNATIONAL TERRORIST OPERATION."**

**"UNLESS LEVI AND CLARENCE KELLEY ARE THROWN OUT OF THE GOVERN-  
MENT, THE LIVES OF ALL CANDIDATES, ESPECIALLY THAT OF PRESIDENT  
FORD, ARE IN DANGER," WARNED LAROUCHE. "THE PATTERN  
OF THREATS AND THE SUBSEQUENT COVERUP BY FEDERAL AGENCIES IS  
EXACTLY THE SAME IN BOTH THIS CASE AND THE ASSASSINATION ATTEMPT  
ON FORD BY SQUEAKY FROMME."**

**LAROUCHE NOTED THAT THE MANSON GANG HAS ALREADY BEEN CONVICTED  
OF MULTIPLE MURDERS AND FRAGS OF HAVING COMMITTED 35 TO 40 KILLINGS.  
"FOR THE FBI TO SAY IN THIS CASE THAT THE MANSON LETTER—NOW  
VERIFIED BY MANSON FOLLOWER SANDRA GOODE—IS 'NOT A THREAT,' IS  
THE STRONGEST EVIDENCE OF THE FBI AND JUSTICE DEPARTMENT'S COMPLIC-  
ITY IN THE ACTUAL MANSON OPERATION."**

**"EVEN THOUGH THE MANSON FAMILY HAS NOW ACCEPTED RESPONSIBILITY**

**(MORE)**

FOR THE LETTER—AS DETERMINED BY A KCBS INVESTIGATIVE REPORTER—  
THERE ARE STILL NO TANGIBLE SIGNS OF A JUSTICE DEPARTMENT OR FBI  
INVESTIGATION." LAROCHE ALSO NOTED THAT THE SAN FRANCISCO POLICE  
DEPARTMENT HAS BEEN SINGULARLY UNCOOPERATIVE IN PROVIDING ANY  
PROTECTION FOR HIS TOUR, AND HE SINGLED OUT LEAA OPERATIVE JEREMIAH  
TAYLOR, THE ASSISTANT POLICE CHIEF IN SAN FRANCISCO, AS THE IN-  
DIVIDUAL RESPONSIBLE FOR VETOING ANY POLICE PROTECTION FOR HIS  
SCHEDULED CAMPAIGN APPEARANCE.

"THE CIRCUMSTANCES OF THE MANSON THREAT AND THE OFFICIAL  
COVERUP MAKE IT ABSOLUTELY CLEAR TO PRESIDENT FORD HIMSELF WHO IS  
SETTING HIM UP FOR ASSASSINATION." LAROCHE NAMED ROCKE-  
FELLER, HENRY KISSINGER AND LEVI AS THE CHIEF THREATS TO DEMOCRACY  
IN THE U.S. TODAY, AND WARNED THAT ANY PRESS OFFICIALS WHO COVER  
UP OR BLACK OUT THE ASSASSINATION THREATS ARE ENDANGERING THEM-  
ERED BY THE MANSON GANG?" ASKED LAROCHE, EMPHASIZING THAT UNTIL  
ROCKEFELLER, KISSINGER AND LEVI ARE BURBED, NO ONE--ESPECIALLY  
PRESIDENTIAL CANDIDATES—IS SAFE FROM MURDER AND ASSASSINATION.
