FBI NACHT UND NEBEL OPERATION AGAINST BRONX LABOR PARTY MEMBER

NEW YORK, FEB. 16 (IPS)—A BRONX, N.Y. LABOR PARTY ORGANIZER HAS BEEN ABDUCTED TWICE IN THE PAST 24 HOURS IN WHAT IS ONLY ONE OF THE MOST RECENT CASES OF JUSTICE DEPARTMENT-ORDERED NACHT UND NEBEL OPERATIONS DIRECTED AGAINST THE USLP AND ITS SUPPORTERS. PAULETTE RICHARDSON, WHOSE HOME WAS BROKEN INTO FOUR DAYS AGO BY FBI AGENTS, WAS KIDNAPPED LAST NIGHT ON HER WAY TO A LABOR PARTY MEETING BY UNIDENTIFIED MEN IN AN UNMARKED POLICE CAR. THE "POLICE OFFICERS" CUT OFF THE CAB IN WHICH SHE WAS RIDING, FORCED THE DRIVER OUT OF THE CAR AND APPARENTLY DRUGGED HER. MRS. RICHARDSON WAS NEXT SEEN THIS MORNING WHEN HER SISTER-IN-LAW FOUND HER LYING IN A STATE OF SHOCK ON HER LIVING ROOM FLOOR. SHE COULD NOT REMEMBER ANY FURTHER DETAILS OF THE ABDUCTION.

IMPLEMENTING BURGER COURT JUSTICE

THE ATTACK ON MRS. RICHARDSON, PART OF A WAVE OF FBI-DIRECTED RAPE ASSAULTS, ARRESTS, AND OTHER VIOLENT ATTACKS AGAINST USLP ORGANIZERS AND SUPPORTERS, COMES AT THE SAME TIME AS THE NATION'S TWO TOP LAW ENFORCEMENT OFFICERS, CHIEF JUSTICE WARREN BURGER AND ATTORNEY GENERAL EDWARD LEVI, HAVE DECLARED THEMSELVES IN A STATE OF INSURRECTION AGAINST THE U.S. CONSTITUTION. U.S. LABOR PARTY PRESIDENTIAL CANDIDATE LYNDON LAROCHE IS PREPARING A STATEMENT ON THE BURGER-LEVI INSURRECTION FOR RELEASE SHORTLY.

SECOND ABDUCTION OF USLPER

EARLY THIS AFTERNOON, AFTER HAVING RETURNED FROM MONTEFIORE HOSPITAL, WHERE SHE RECEIVED MEDICATION TO CALM HER NERVES, MRS. RICHARDSON WAS ABDUCTED FROM HER HOME BY AN UNCLE, WHO PHYSICALLY FORCED HER INTO HIS CAR DESPITE PROTESTS FROM BOTH MRS. RICHARDSON HERSELF AND HER SISTER-IN-LAW. SHE WAS TAKEN TO A NEARBY RELATIVE'S HOME, WHERE OTHER MEMBERS OF THE FAMILY PRESSURED HER TO SEVER ALL CONTACT WITH THE LABOR PARTY.

ON FEB. 12, TWO FBI AGENTS HAD "VISITED" MRS. RICHARDSON'S HOME. WHEN SHE INITIALLY REFUSED TO ADMIT THEM, THEY BEGAN TO KICK IN THE DOOR AND PICK OPEN THE LOCK. ONCE INSIDE, THEY INTERROGATED HER ABOUT HER RECENT ACTIVITIES AND ABOUT HER HUSBAND, WHO IS A MARINE ON ACTIVE DUTY. MRS. RICHARDSON RESPONDED TO THIS INITIAL HARASSMENT BY CONTACTING HER ATTORNEY AND BY BRIEF-

ING THE USLP REGIONAL CENTER. THE PAST 24 HOURS' NACHT UND NEBEL ESCALATION FOLLOWED.

KEY FEATURES OF THE FBI ATTACK ON MRS. RICHARDSON ARE IDENTICAL TO THE RECENT FBI/LEAA CAMPAIGN AGAINST INDIANAPOLIS LABOR PARTY MEMBER ROXANNE GRIMMIUS, WHO WAS COERCED, UNDER FBI PRESSURE, INTO SUBMITTING TO BEHAVIOR MODIFICATION AT AN LEAA-FUNDED HOSPITAL. ALTHOUGH HARD EVIDENCE SHOWING FBI MANIPULATION OF MRS. RICHARDSON'S FAMILY HAS NOT BEEN ASSEMBLED AT THIS POINT, IT IS KNOWN FROM THE GRIMMIUS CASE AND FROM THE 1974 ABDUCTION-BRAIN-WASHING OF PHILADELPHIA LABOR COMMITTEE ORGANIZER GAIL ROESHMAN THAT SUCH FBI MANIPULATION OF RELATIVES IS "STANDARD" FBI PRACTICE.
