# *The Dynamic Shifts to Recovery—Or Else*

With the defeat of the British Copenhagen agenda, a new opportunity has opened up for all mankind. The evil dynamic of globalization, which has dominated the world for the past 40 years, has suffered a major blow, and it is now time for the mass strike dynamic which emerged with such drama in the United States in August, and which has defeated British plans for global dictatorship in Copenhagen, to assert itself *positively*, with a program for recovery.

Without question, Copenhagen was a victory for the principle of national sovereignty, enforced by the growing alliance among China, Russia, and India. Even President Obama was forced to bow to that reality in Copenhagen—and that’s an excellent development. But now, the United States itself has to join in that revolution in statecraft, not just for the sake of our nation, but for humanity as a whole. Lyndon LaRouche emphatically stated on Dec. 22 that emergency action must be taken in the U.S. within the next few weeks—or disaster will strike.

Indicative of the great opportunity which has arisen, was an interview given Dec. 19 to the London *Sunday Express* by the Russian Railways Minister Vladimir Yakunin. Yakunin, one of the closest collaborators of Russian Prime Minister Putin, declared that he is pursuing projects to link the world by rail, including by constructing the Bering Strait tunnel that would connect North America and Eurasia. “With new rail links planned through Alaska and eastern Russia, the tunnel would help enable freight and passenger trains to run from the U.S. to London on uninterrupted tracks,” Yakunin told the *Express*. In pursuit of what he calls a “renaissance of railways,” Yakunin said he was “in contact with countries in Latin America, Africa,

and with Arab countries and China. It’s in everyone’s interest to develop railways.”

Yakunin’s concept dovetails precisely with the concept of the Eurasian Land-Bridge, which Lyndon and Helga LaRouche have been championing for decades. It represents a concrete realization of the dream of uniting the continents in the common economic interest of nation states.

But, to accomplish this, Americans must move *immediately* to shift the agenda in the United States. If the U.S. continues on the course of devastating collapse, *no other nation* will survive the wave of physical economic implosion that will follow.

The emergency measures that must be taken immediately were outlined by LaRouche Dec. 22:

First: Implement Glass-Steagall protections for the commercial and savings banks, thereby wiping trillions of dollars of worthless paper off the books (the bailout included), and establishing de facto a credit system;

Second: Enact LaRouche’s Homeowners and Bank Protection Act of 2007, as protection against the mass of foreclosures that is about to go through another huge ratchet up;

Third: With the banks freed of the toxic waste, have the Federal government issue credit to begin emergency employment programs, to immediately create at least 2 million jobs in productive areas of the economy, such as transport, nuclear power, and the like;

Fourth: Have the government move toward linking up with Russia, China, and India for an international fixed-exchange-rate credit system, to launch world recovery.

Sound good? Then let’s get going, and *create* a Happy New Year in 2010!
