

supposed to reinvigorate regional economic institutions through a revamped Inter-American Development Bank (IADB) and its private investment arm, IDB Invest. The emphasis is on “unlocking substantial amounts of *private sector financing investment*” which the Biden Administration has never had success in raising. Another pillar emphasizes creating “more resilient supply chains,” which simply means reducing dependence on China. Depopulation will be advanced by promoting low technology “clean energy jobs,” decarbonization, and increasing renewables as part of the energy grid. “Sustainable and inclusive trade” will be based on existing free-trade agreements that are to be the foundation of this boondoggle. No new ones will be signed, and no country will be granted more market access to the U.S.

The other major initiative on migration reflected in the Los Angeles Declaration on Migration and Protection signed June 10, is fraudulent. This is a non-binding resolution which is intended to serve as the basis for bilateral migration deals the Biden administration hopes to sign with individual countries, based on the concept of “shared responsibility.” That is, with the promise of more U.S. funding, governments that are now struggling under the economic burden of hosting hundreds of thousands of immigrants from Venezuela, Haiti, Cuba, Nicaragua and other countries must now act as enforcers, preventing the migrants from leaving their countries to head north to the U.S. The Biden administration is promising to provide more funds to governments to help them pay for more social services, legal protection, and job training for migrants.

Besting China?

Jake Sullivan boasted that all these wonderful new initiatives will be far superior and have a more lasting impact on the lives of the people of the Americas than anything China offers with its “extractive” projects—his term for BRI projects. In remarks to *Washington Post* columnist Ishaan Tharoor, published June 10, Chile’s former ambassador to China, Jorge Heine, responded to the Summit’s proposals saying, “It all looks very thin.” Today, China is the first or second largest trading partner of most nations in Ibero-America and the Caribbean and is engaged in developing major infrastructure and construction projects across the region. Heine noted,

When U.S. authorities visit Latin America, they often talk about China and why Latin American countries should not deal with China. When Chinese authorities visit, all the talk is about bridges and tunnels and highways and railways and trade.

One vision, Heine added, is clearly “more attractive” than the other. He noted that most governments would prefer the U.S. model for reasons of shared democratic and cultural values:

But the real challenge is development.... When China comes and offers trade and financing, that is welcome. That is the main priority. Latin Americans are not in the business of international power competition.

OPEN LETTER FROM IBERO-AMERICA TO MR. BIDEN

‘End Your Strategy of Using Ukraine to Destroy Russia! Stop the Danger of Nuclear War!’

June 11—Led by the LaRouche Citizens’ Movement of Mexico and friends in Argentina, Schiller Institute activists from many Ibero-American countries sent their Presidents and other officials, an “Open Letter from Ibero-America to Mr. Biden” on the eve of the beleaguered Summit of the Americas which took place June 6–10 in Los Angeles. The Open Letter went out the week of June 3, signed by a select number of citizens from the region. Its message: “End Your Strategy of Using Ukraine to Destroy Russia! Stop the Danger of Nuclear War!” The full text follows.

“The Summit of the Americas, which will take place June 6–10 this year, should submit a blunt resolution from the Presidents of Ibero-America to U.S. President Joe Biden:

1. End your strategy of using Ukraine to destroy Russia.
2. Stop NATO’s extension and expansion toward the Pacific (Global NATO), since if that is not done, we are

heading toward a frontal war against China, which at this point in human history would be truly insane, and would drive us toward general thermonuclear war.

That is why the international community should call for an immediate ceasefire in Ukraine, sanctions to be lifted against Russia, and an international conference to be convoked on a New Security and Economic Development Architecture for all nations, which takes into account the demands of the Russian government for security on its borders, as the Schiller Institute proposes in its recent [call](#).

President Biden: The economic and financial sanctions against Russia are having a boomerang effect on the world economy. We are already in worldwide stagflation and it will get worse if an economic and financial war is opened against China. Decoupling the financial system and economies of the trans-Atlantic axis plus Japan, Australia, and South Korea, from the economies of Russia and China would trigger a general economic and social collapse much worse than the collapse of Europe and Asia during the 14th century bubonic plague. That alone could mean the disappearance of the

global civilization which we inherited from the great 15th and 16th century European Renaissance.

Moreover, the entire world faces a general debt crisis stemming from the \$1.9 quadrillion speculative bubble, which is the underlying cause of the hyperinflationary process aggravated by illegal sanctions.

You know the solution to this economic breakdown: You told CNN on December 15, 2016, that the biggest mistake in your political career was your vote in 1999 in favor of the cancellation of Franklin Roosevelt's Glass-Steagall Law by President Clinton and the Congress.

Now is the time to reinstate it!

Franklin Roosevelt's economic system must be re-established worldwide. Glass-Steagall must be reestablished across the planet along with a policy of economic relations and good will with Russia and China, so that, together with India, these four superpowers can rid themselves of their common enemy, the dark forces of the financier speculator interests opposed to human progress—the Neanderthal embers of McCarthyism and the Cold War—and found an economic system capable of eliminating poverty throughout the world. This is the path to reestablish the economic power of the United States and the whole Ibero-American region.

Likewise, a comprehensive economic and social plan to finally address the consequences of the conflicts and wars in Asia and Africa should be formulated as part of, and complementary to, China's strategic Silk Road plan.

With all due respect for the people of the United States, they would be wise to accept that the world today can no longer be unipolar. There are other powers whose place in the new concert of nations should be recognized under the 21st century concept of multipolarity.

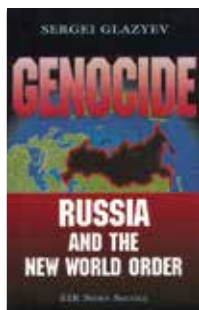
